

Triple J's Rolling Video Games
**Concession (Popcorn/Snow cone/HotDog Steamer/
Nacho Cheese Warmer/Cotton Candy) Rental Agreement**

This agreement is made between **Triple J's Rolling Video Games** (Owner)

and _____ (Renter)

Renter shall pay **Triple J's Rolling Video Games** for the rental of concession equipment for the duration of your party/event rental with **Triple J's Rolling Video Games Mobile Gaming Theater**.

- **Renter will have the option of purchasing additional supplies for the Popcorn/Snow cone/Cotton Candy machine such as: popcorn, syrups snow cone cups, ice and cotton candy floss.**
- **Equipment must only be used at the location of the Triple J's Rolling Video Games Mobile Gaming Theater. Full payments must be made by the day of your party/event. Triple J's Rolling Video Games is not responsible for any injuries that may occur while machine is in operations. Renter must advise Triple J's Rolling Video Games immediately at**

(888) 874-7535 if equipment has any difficulties, damages, or malfunctions. Renter is responsible for making electrical access for all concession equipment rental.

All concession equipment must be cleaned up and wiped down prior to being returned if equipment is not cleaned a fee of \$25 each be charged.

CANCELLATION:

This agreement cannot be cancelled, except in writing no later than 7 days prior to the event, by either the **Client or Triple J's Rolling Video Games**. If the Client initiates the cancellation, **Triple J's Rolling Video Games will retain the non-refundable deposit paid at time of reservation**. Client will hold **Triple J's Rolling Video Games** harmless in the event of illness, injury, act of God or any other situation beyond the control of **Triple J's Rolling Video Games** that prevents **Triple J's Rolling Video Games** from performing. In the event **Triple J's Rolling Video Games** must cancel the reservation for any reason, Client will be entitled to full return of deposit, and agrees not to pursue any other damages against **Triple J's Rolling Video Games** or its owner resulting from the cancellation.

PROVISIONS:

Triple J's Rolling Video Games requires access to the desired set-up area at least by the start time. In addition, 30 minutes are required after the conclusion of the service period to take down and removal. The Client is responsible for providing a sturdy, level table capable of supporting at least 150 pounds. **Triple J's Rolling Video Games** also requires at least 1 110-volt circuit within 10 feet of the desired set-up area that adheres to contemporary safety standards and supplies at least 15 amps. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. **Triple J's Rolling Video Games** reserves the right to use any pictures from the event in advertising. In the event that **Triple J's Rolling Video Games** cancels the contract, **Client's deposit will be refunded immediately**.

LIABILITY:

Client agrees to assume full responsibility and liability for any and all claims arising out of the use of the concessions or its attendants. **Triple J's Rolling Video Games** will not be held liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use or rental of the Concession Machines. Client will indemnify **Triple J's Rolling Video Games** against, and hold **Triple J's Rolling Video Games** harmless from all claims, actions, proceedings, costs, damages, and liability including attorney's fees, arising out of, in connections with, or resulting from the rental of **Triple J's Rolling Video Games** concession.

PAYMENT TERMS:

A 50% of your Total rental cost, non-refundable deposit is required to reserve a **Triple J's Rolling Video Games** concession machine. To confirm this agreement, return one signed and completed copy of this contract along with the deposit within 5 days of the reservation. In the event the signed contract is not returned, payment of the deposit shall be deemed full approval, acceptance and agreement to the terms and conditions contained in this contract. The balance is due NO LATER than 7 days prior to the event and can be paid in cash or by major credit or debit card. Once the balance is paid, no refund shall be made.

Important Notice: Damage of the concession equipment will incur a cost of \$400.00 for each damaged machine
